Sub: - Import of valves through various Ports in India clandestinely without import licence under Gas Cylinders Rules, 2016

Dear Sir.

It has been reported by

that various types of valves intended to be fitted to various types of cylinders are coming into India from foreign origin clandestinely through various ports of India without having import licence in Form D under Gas Cylinders Rules, 2016.

In this connection, it is requested to kindly refer to the rule No. 3(a), 29(2) of Gas Cylinders Rules, 2016 which prohibit the import of valves without proper Form D licence under Gas Cylinders Rules and also kindly refer to Rule 31 & 32 of the said Rules...

There is also a clear procedure for obtaining import licence from this organisation in Form 'D' for import of valves intended to be fitted on the cylinders and to produce the same to the Commissioner of Customs before clearing the same from the customs.

In view of the above, it is requested to kindly take further necessary action to prevent clandestine import of valves.
